Financial and Statistical Reports

Finance Director Allison Halron reviewed the financial information distributed to the Board for the period ending March 31, 2020. Information only, no action taken.

New Business

Wet Well Cleaning and Disposal Services: Water Reclamation Director Kendra Stanciel presented a recommendation on Wet Well Cleaning and Disposal Services.

Clayton County Water Authority owns and operates forty-one raw sewage lift stations and three water reclamation facilities that have pump stations, wet wells and other basins that accumulates grit and grease over time. These wet wells, basins and lift stations require

regular cleaning or removal of the grit and grease to prevent operational problems with the control systems and pumps located in these areas.

Recommendation:

CCWA staff recommended awarding the bid to Allsouth Environmental Services, Inc. for a bid price of \$1.70 per gallon. This award is contingent upon the CCWA Board authorizing the General Manager to sign the contract and the Bidder providing the necessary insurance requirement and executing the contract.

UPON MOTION by Dr. Cephus Jackson and second by Marie Barber, it was unanimously

RESOLVED to award the Wet Well Cleaning and Disposal bid to Allsouth Environmental Services, Inc. for a bid price of \$1.70 per gallon; contingent upon the bidder providing the necessary insurance requirement and authorizing the General Manager to sign the contract.

Flint River Easement Condemnations Recommendation: Program Management and Engineering Director Kelly Taylor presented a recommendation on the Flint River Easement Condemnations.

CCWA is currently completing design activities for the Flint River Outfall East Phase 1 Pipeline Replacement Project. A bid recommendation is scheduled to be presented at the June 2020 Board of Directors meeting.

The replacement project will begin on the east side of the Flint River, north of Highway 138 to an area north of Valley Hill Road. As part of the design process, CCWA staff collect temporary construction easements and permanent easements, where necessary. This is an extensive process that involves several communications with all applicable property owners. Staff has exhausted communication and negotiation avenues with the three properties and for various reasons, have not been able to acquire easements for three properties. The following parcels require permanent and/or temporary construction easements:



19,500 lb. GVWR Crew Utility Trucks Purchase Recommendation: Stormwater Director Kevin Osbey presented a recommendation on the purchase of three 19,500 lb. GVWR Crew Utility Trucks.

The Clayton County Water Authority Stormwater Utility's maintenance department operates with four crews. Three of the four crews, perform a variety of maintenance activities on stormwater infrastructure such as pipe repair/replacement, catch basin repair, and drainage ditch repair. One crew mainly performs ditch maintenance along the road right of way. Each of these crews have 4 members and often transit to various worksites together. At present, each crew has utility trucks that were purchased in 2010.

After nearly 10 years of service, all three crew utility trucks have been evaluated based on mileage, age, and maintenance costs. The summary of this evaluation has all three trucks exceeding the point value for replacement recommendation. The maintenance performed, for each truck, has exceeded 50% of the original costs. Staff is requesting to replace all three crew trucks this fiscal year.

Recommendation:

CCWA staff recommended purchasing three (3) new 2020 Ford F550 Utility Crew Trucks with Utility Bodies for \$59,485.62 each under State Contract #99999-001-SPD0000155. These crew trucks will replace three existing crew trucks in Stormwater. Total cost for all three trucks is \$178,456.86.

UPON MOTION by Dr. Cephus Jackson and second by Vivian Baldwin, it was unanimously

RESOLVED to purchase three (3) new 2020 Ford F550 Utility Crew Trucks with Utility Bodies for \$59,485.62 each under State Contract #99999-001-SPD0000155.

78% Bulk Sulfuric Acid Rescind & New Award Recommendation: Water Production Director Coty McDaniel presented a recommendation on the 78% Bulk Sulfuric Acid Rescind & New Award.

On March 4, 2020, the Board approved annual chemical bid recommendations. The bid for 78% Bulk Sulfuric Acid was provided at a per gallon basis. Brenntag was awarded the bid for 78% Bulk Sulfuric Acid at a rate of \$0.25/Gallon. During the award acknowledgment process it was discovered that Brenntag made an error and intended to bid at rate of \$0.25/Pound rather than per Gallon. The discrepancy of the unit of measure substantially impacted the unit price for the product from Brenntag. A phone meeting between Brenntag and CCWA was conducted on April 30, 2020 to discuss the matter. Brenntag requested to retract their bid due to the error.

Recommendation:

CCWA staff recommended rescinding the award to Brenntag for 78% Bulk Sulfuric Acid and instead awarding the bid for 78% Bulk Sulfuric Acid to Southern States Chemical, the lowest responsible responsive bidder, at a rate of \$1.69099 per gallon.

UPON MOTION by Dr. Cephus Jackson and second by Marie Barber, it was unanimously

RESOLVED to rescind the award to Brenntag for 78% Bulk Sulfuric Acid and instead award the bid for 78% Bulk Sulfuric Acid to Southern States Chemical, the lowest responsible responsive bidder, at a rate of \$1.69099 per gallon.

<u>Huie Nature Preserve Foundation Recommendation:</u> Assistant General Manager Teresa Worley presented a recommendation on the Huie Nature Preserve Foundation.

Recommendation:

CCWA staff recommended approval of the following:

- Allocate \$100,000 in funding to match Federal funding in the amount of \$160,000 for the 319h grant along with approval for the GM to sign contract.
- Selecting Sustainable Water Planning & Engineering for the Huie Site Green Infrastructure Parking Lot Final Design, Permitting, and Bidding Services at a total cost of \$46,500.
- Allocate \$146,500 from the CCWA Timber Fund to the Huie Nature Preserve Foundation.

UPON MOTION by Dr. Cephus Jackson and second by Vivian Baldwin, it was unanimously

RESOLVED to allocate \$100,000.00 in funding to match the Federal funding in the amount of \$160,000 for the 319h grant; and approving the GM to sign the contract; along with selecting Sustainable Water Planning & Engineering for the Huie Site Green Infrastructure Parking Lot Final Design, Permitting and Bidding Services at a total cost of \$46,500.00.
