Clayton County Water GM Makes History as First African American President of the Georgia Association of Water



CCWA's General Manager H. Bernard Franks made history on July 12 as he took over as President of the Georgia Association of Water Professionals (GAWP) during the association's annual conference in Savannah.

Franks is the first African American to serve in this role. He brings more than 25 years of service at CCWA, a passion for the water industry, and a long record of service to GAWP throughout his career.

"I am proud to have served in the water industry now for over 25 years. As servant leaders, we should all give thanks for this opportunity to be caretakers of the most valuable, life-sustaining natural resource in the world - water," Franks adds. "As water professionals we grow and prosper due to our diversity, humility, integrity, and innovation."

Franks will lead the Association to its 90th anniversary. He will oversee the development of a new Strategic Plan for the Association, to focus on how GAWP will assist with the most critical needs of the Georgia water professionals in the next decade. His theme for his leadership year is "Why Water Matters" as he works to further the understanding and appreciation of the industry, and the work of water professionals.

"Bernard inspires me to think big about the future of the water profession, and how the association can serve and lead to more innovation and protection of precious water resources," says GAWP Executive Director Pam Burnett. "His style of servant leadership brings people together to do more than they could as individuals, to build a

thoughtful and supportive community of water professionals."

"We are extremely proud of Mr. Frank's ascension to president of the Georgia Association of Water Professionals. His commitment to CCWA, and the water industry, has made him one of the most respected water professionals in the nation," adds CCWA Board Chair Robin Malone. "He is knowledgeable, forward thinking and a visionary; all attributes necessary to lead GAWP over the next year."

Westervelt Honored for 18 Years of Service on CCWA Board

CCWA Board Member John Westervelt was honored during the August Board Meeting for 18 years of service on the board. Clayton County District 3 Commissioner Felicia Franklin presented him with a proclamation on behalf of the Board of Commissioners. The CCWA Board and GM H. Bernard Franks presented Mr. Westervelt with a service award for all of his contributions.

Milestones of his service include:

- Appointed February 18, 2003
- Served as Secretary/Treasurer from 2012 - 2018
- Continued financial security by achieving a Bond Rating of AA+ from Standard & Poor and refinancing several CCWA bonds to save millions in interest payments and keep rates lower than most metro Atlanta water utilities
- Implementation of a unified Stormwater Utility
- Completion of the E.L. Huie, Jr. Constructed Treatment Wetlands
- Completion of a \$10 million meter replacement project
- Creation of a dedicated Call Center and other significant customer service improvements
- Renovation/expansion of the HQ Building
- Completion of the W.B. Casey WRRF Polishing Plant

CCWA's Newman Wetlands Center Receives Tourism Grant

Clayton County's Tourism Authority Board chose to fund CCWA's "Welcome to the Wetlands!" project. The received grant along with CCWA matching funds will be used to make the Newman Wetlands Center (NWC) more accessible and to better tell the NWC's story.

The upgrades will include a new website that includes a page dedicated to accessibility, an interactive trail map featuring audio descriptions, and new educational videos. They will also include an offroad power chair that guests with accessibility difficulties can use to explore, hiring an accessibility consultant to help us update and plan for the future, and marketing materials to reach folks who might not know we exist.
