#### **Section 2: General Information**

#### 2.1 Intent and Purpose

The Clayton County Water Authority (CCWA) intends to purchase three (3) Dewatering Pumps - One (1) Four Inch (4") Dri-Prime Silent Pump, One (1) Six Inch (6") Dri-Prime Silent Pump, and One (1) Four Inch (4") Dri-Prime Pump that meet the specifications and requirements respectively set forth in this RFB and will be the most advantageous to CCWA.

At present, the CCWA operates with two pumps. Unfortunately, one of these pumps has malfunctioned to an extent where repair is no longer feasible. These pumps are essential for managing situations where sewer overflows cannot be promptly controlled. Dewatering pumps play a crucial role in bypassing issues, diverting flows to alternative routes until the problem is rectified. The demand for dewatering pumps at CCWA has escalated due to the aging sewer system, heightened occurrences of operational and maintenance blockages.

The bids shall be delivered or mailed to the Clayton County Water Authority, located at 1600 Battle Creek Road, Morrow, Georgia 30260, in a sealed package, on or before **Tuesday**, **May 7**, **2024**, at **10:00 a.m.** (**local time**). Use the bid package label provided with this RFB (Attachment A).

#### 2.2 Bid Evaluation

To qualify for consideration, the bidder must adhere to all specifications outlined in Division 4. The bid will be awarded to the lowest responsive responsible bidder(s) offering the lowest price while meeting the specified equipment standards including the specific conditions as outlined in Division 4 and will be the most advantageous to the CCWA.

#### 2.3 Addendum

Bidders may ask questions regarding this bid prior to the bid opening.
