• Program Kickoff: CCWA proudly launched the SLBE Program, bringing 33 small businesses into the fold, with outreach extending to Clayton, DeKalb, and Atlanta communities.

- First Certifications: Established foundational partnerships with certified SLBE businesses, supporting local economic growth.
- Strengthened partnerships with local leaders to advocate for small business growth.
- · Record Growth: SLBE-certified firms grew by 31%, as CCWA expanded its support to more businesses across multiple counties 2018
 - Focused Training: Business development workshops on risk management provided critical insights for SLBEs
- Supporting Local Contractors: Woolpert, a prime contractor for CCWA, engaged SLBE firm DD Sewer as part of the Sewer Systems 2020 Evaluation Survey Contract awarded in 2020. Woolpert's utilization of DD Sewer reached 23% of the contract's total, aligning closely with CCWA's SLBE goal of 25% and contributing \$696,648.73 to local business growth out of the \$3,068,543.62 contract total.
 - Graduation Lakeshore Engineering: Lakeshore Engineering exemplified potential of CCWA's SLBE Program by evolving from an SLBE-certified firm to a prime contractor. Through consistent competitive bidding and project success, Lakeshore exceeded the small business revenue threshold. Key projects included the Smith HSPS and the WPP Chemical Feed System Storage Replacement. This growth story highlights how the SLBE Program fosters advancement for small businesses

Educational Expansion: Hosted workshops, including "Specifics of Bidding," attended by businesses eager to enhance bid readiness RCM Restoration Services completed its first major project, setting a standard for other vendors entering the SLBE Program

Increased SLBE bid pool to \$30 million.

Continuous Support: CCWA reinforced its 2017 commitment to local businesses through targeted outreach and guidance sessions

> Financial Milestone: CCWA reported \$12.5 million in SLBE spending, representing a 13% utilization of certified firms

Expansion: Grew to 329 certified increasing local economic value.

SLBE Significant growth in utilization, 2021 supporting infrastructure projects.

> Reached \$13.8 million in SLBE spending, with 31% certified firm utilization.

2023 • Supporting Business Development: Hosted the "Are you Bonded & Insured?" workshop in April, where Jessica Reno of Nielson Bonds shared insights, connecting SLBEs like Allen Carter of Carter Construction with critical bonding resources which allowed them to increase his company's bonding capacity.

Growth and Commitment to Local Business: CCWA hosted workshops on topics like "Goal Setting" and "Follow Up," aiming to equip SLBE-2024 certified firms with skills for lasting success.
