Who WE ARE

The Clayton County Water Authority (CCWA) provides essential water, sewer, and stormwater services to nearly 300,000 residents across Clayton County and its six cities: Morrow, Forest Park, Riverdale, Jonesboro, Lovejoy, and Lake City. Founded in 1955, CCWA was built on a strong foundation laid by visionary staff and board members who were committed to overcoming challenges by finding innovative solutions. This spirit of innovation continues to drive the Authority today.

With a dedicated workforce of approximately 400 water professionals across 12 departments, CCWA operates daily to deliver quality services to our community. Our Board of Directors, made up of seven members appointed by the Clayton County Board of Commissioners, serves on a part-time basis for five-year terms, with the possibility of reappointment.

CCWA operates five raw water reservoirs, providing the capacity to produce up to 42 million gallons of potable water daily. We also treat up to 39.4 million gallons of wastewater each day. Despite limited surface and groundwater supplies, CCWA has developed a sustainable water supply using constructed treatment wetlands that recycle treated wastewater. This innovative process allows the Authority to return more than 14 million gallons of reuse water to the system every day. Additionally, in 2021, CCWA enhanced its environmental impact by reintroducing treated flows to the Flint River via the new W.B. Casey Water Resource Recovery Facility Polishing Plant, improving the river's health and benefiting neighboring communities downstream.

CCWA's commitment to fiscal responsibility is reflected in its management of two enterprise funds, which operate like a typical business and receive no tax dollars. The Water and Sewer Fund has an annual budget of \$134.1 million and is responsible for maintaining \$622.3 million in infrastructure, including 1,500 miles of water distribution pipes and 1,400 miles of sewer conveyance pipes. CCWA is committed to replacing and rehabilitating critical underground infrastructure as needed. The Stormwater Fund, with an annual budget of \$10.8 million and \$67.9 million in infrastructure assets, oversees the maintenance of 500 miles of stormwater pipes. CCWA has successfully managed its finances, with no outstanding revenue bonds following the maturity of its 2012 series bonds in May 2023.

Clayton County Water Authority's focus on innovation, sustainability, and fiscal stewardship ensures the continued delivery of reliable services to its community. By prioritizing infrastructure maintenance, environmental responsibility, and efficient resource management, CCWA remains a leader in water service provision, building a secure and sustainable future for Clayton County and its residents.



Fix a Leak Week

Founded by the United States Environmental Protection Agency in 2009, National Fix a Leak week was created to bring awareness to how household leaks contribute to the trillions of gallons of water wasted annually in the U.S. CCWA celebrated National Fix a Leak Week by providing leak kits to customers and educating the community on household leaks at our Headquarters lobby and Home Depot.



Household Hazardous Waste Collection Day

Sponsored by CCWA's Stormwater Utility, Household Hazardous Waste Collection Day provides Clayton County residents with the opportunity to dispose of items that have detrimental effects on our environment if they enter our waterways. Items ranging from household paints and fire extinguishers to motor oil and transmission fluid are collected and properly disposed. Thanks to our community, we were able to collect over 64,000 pounds of waste at the 2024 Collection Day event.



National Drinking Water Week

The American Water Works Association founded National Drinking Water Week to celebrate water professionals and recognize the important role water plays in our daily lives. In May, CCWA kicked off our National Drinking Water Week celebration with our annual Open House event at the Terry R. Hicks Water Production Complex. Members of the community were invited to take a tour of our plant and see what goes on behind the tap to provide our quality tap water. Customers who visited our headquarters lobby throughout the week were able to converse with staff from our Water Quality Lab and enjoy ice cold water provided by our Tap on the Go Team.



Rivers Alive Stream Cleanup

The CCWA Stormwater Utility hosts an annual Rivers Alive Stream Cleanup in October where community volunteers can help clean trash and debris from a local waterway. This event is part of the statewide Rivers Alive volunteer cleanup event that targets all waterways in the state of Georgia, including streams, rivers, lakes, beaches, and wetlands. For the first time, CCWA hosted our cleanup event at Mundy's Mill High School. Thank you to our volunteers who were able to collect 1,640 pounds of trash from the local stream.



Wetlands & Watershed Festival

On the first Saturday of November, the Newman Wetlands Center hosts the Wetlands & Watershed Festival, an inclusive, family-friendly event designed to connect our community with Nature in a fun way. 
CCWA Progresses to Construction Phase of \$159 Million Biosolids **Facility Upgrade**

Clayton County Water Authority (CCWA) is known by industry peers for our dedication to implementing innovative treatment processes. This includes the introduction of our pelletizing facility in 1980, which uses a complex solids treatment method to process biosolids into a Class "A" product. Registered with the State of Georgia under the trade name Agri-Plus 650, this product is sold as a high-quality fertilizer.

However, the current pelletizing facility at the W.B. Casey Water Resource Recovery Facility (WRRF) has reached the end of its service life and requires more capacity as the county has grown. In response, CCWA identified this as a need in our Strategic Master Plan and we began planning for this investment. These improvements will allow CCWA to maintain our dedication to sustainability while enhancing the W.B. Casey WRRF biosolids capacity, increasing efficiency, reducing operating costs, improving safety for our staff, and improving the quality and marketability of the pellets.


The construction phase of the project, estimated at \$159 million, officially kicked off the design phase in March 2022. In March 2024, construction activities began and will be completed in March 2027. This is one of the many ways CCWA acts on our commitment to invest in the community of today and tomorrow.





Water & Your Health: CCWA Employees Work to Identify Material of **Over 4.000 Service Lines**

As our community's water provider, Clayton County Water Authority is at the forefront of public health and committed to providing safe drinking water that meets all state and federal requirements. In recent years, there has been a greater focus in communities across the country on "lead in drinking water." Lead does not naturally occur in treated drinking water. Clayton County Water Authority's (CCWA's) drinking water is lead-free when it leaves our treatment plants. As water travels through our system to your faucet, lead can enter the water through service lines or the corrosion of plumbing materials in your private home or building.

In 2021, the U.S. Environmental Protection Agency (EPA) revised the Lead & Copper Rule (LCR) to include a new requirement that all water utilities across the country must create initial inventories of their water service lines and connections to find any lead service line or connection that may exist in a water system. These inventories must also include the customers' side of the water meter.

It is important to note that we have not found any lead service lines and have a high degree of certainty that lead lines were not common in our community. However, as an additional effort to help minimize any possible lead exposure from drinking water, and in accordance with the LCR Revision, the initial inventory of CCWA's water service lines and customer service lines had to be conducted.

Homes built after 1986 were identified as non-lead due to the Safe Drinking Water Act, which banned the use of lead in new water pipes. CCWA pulled together a team focused on identifying the unknown services lines for homes built before 1986. The team developed a plan of action that was efficient and timely, with little to no disruption to our customers. Between March and July of 2024, a special crew of employees were able to identify more than 4,000 of the unknown lines. Customers who our initial inventory determined had a service line made of galvanized material and customers whose material is considered unknown based on the LCR Revision criteria were notified. Our team is working to develop a plan to complete the inventory by the required EPA deadline of 2027.



The initial inventory work for our system was completed and made available to the public by October 16, 2024. The inventory may be accessed through our public portal, which is available on our Lead Awareness page at

Customer Accounts Transitions Forest Park Office to Self Service Payment Hub



In February 2024, Clayton County Water Authority transitioned the Forest Park customer service office to a self-service payment hub. The payment hub includes a payment kiosk, equipped with several special features designed for our customers including English, Spanish, and Vietnamese language options. Customers can conveniently pay their bills 24/7 without any service fee charges, whether using cash, check, or card. With its user-friendly interface, this kiosk is designed to streamline customer visits and make things smoother than ever before.

A ribbon-cutting ceremony was held to celebrate the occasion. In April 2024, the Self-Service hub was closed indefinitely due to a fire inside the office building.

Affordability Programs Provide More than \$137,000 in Assistance to Customers

Clayton County Water Authority funds its Affordability Programs (Hardship Assistance and Low-Income Discount) from cell tower revenue and its alliance partnership with Gas South. Both programs are administered by the Clayton County Community Services Authority.

Hardship Assistance was created in late 2006 and has expanded as funding sources grew over the years. CCWA's Low-Income Discount Program was created in May 2021 to replace the Senior Discount and Veteran's Discount Programs. The program allows all customers under 150% of the federal poverty level guidelines to receive monthly discount up to \$5.00 on their water and sewer bill (\$2.50 off water and \$2.50 off sewer).

In 2024, CCWA's Affordability Programs were able to provide more than \$137,000 in assistance to 1,108 customers.

Small **LOCAL BUSINESS** Enterprise Program

The Clayton County Water Authority's SLBE Program celebrated a decade of transformative partnerships and economic empowerment in 2024, marking a milestone year of growth, opportunity, and collaboration for small and local businesses. Over the past 10 years, CCWA has invested more than \$111 million in SLBE Firms as prime contractors on annual contracts and projects – an incredible testament to our appreciation and commitment to supporting small businesses.

In 2024, CCWA proudly certified 41 new SLBE firms, reaffirming our dedication to expanding opportunities for small businesses to thrive. These certifications contributed to numerous contract awards in critical service areas, including:

The pinnacle of the year was the 10th Annual SLBE Mixer, a celebration of partnerships, progress, and impact. This event brought together CCWA leadership, SLBE firms, engineering consultants, and prime contractors for an inspiring evening of networking and recognition. A key highlight was the debut of the SLBE Anniversary Video, featuring heartfelt testimonials from CCWA staff, showcasing the critical role SLBE firms have played in advancing CCWA's mission. The Waves of Growth visual showcase further highlighted the program's remarkable achievements over the past decade, underscoring the enduring impact of SLBE-certified firms on the local economy.

Business development remained a top priority in 2024, with CCWA hosting impactful workshops such as the Capability Statement Refresh, led by F. Hill & Associates, which explored Al's role in business development, and the Chaos to Confidence seminar, which provided practical insights for building sustainable businesses. These initiatives empowered SLBE firms with tools and strategies to compete effectively in the marketplace and position themselves for long-term success.

The success of the SLBE Program is a result of collaboration and dedication from SLBE firms, CCWA leadership, and valued community partners such as the Clayton County Chamber of Commerce and Central Services. Together, these partnerships have driven economic growth, strengthened local businesses, and supported CCWA's mission of delivering exceptional service to the community.

As we look ahead to 2025, CCWA is excited to expand SLBE participation by 20%, launch a new Business Development Program, and continue creating opportunities for networking, education, and growth. The next decade promises even greater success as we build on the strong foundation laid by the SLBE Program's first ten years.

CCWA'S **NATIONALLY RECOGNIZED** Safety Program

After an accident that resulted in an employee injury, CCWA staff began exploring ways to enhance safety for workers in roadways and right-of-ways. This led to the creation of the Mobile Illuminated Traffic Control Hub, or M.I.T.C.HTM.

M.I.T.C.HTM is a fully enclosed 6'x12' trailer equipped with exterior LED lighting to illuminate the work zone, flashing strobes for warning, and an LED arrow board to direct drivers. All graphics are reflective for enhanced visibility, and the interior contains all necessary components for setting up safe work zones in roadways and right-of-ways. M.I.T.C.HTM quickly gained popularity among employees, and the growing demand led to the development of M.I.T.C.HTM 2.0, an upgraded version featuring advanced safety features.

M.I.T.C.H™ 2.0 offers several significant improvements over the original design, including a larger trailer with double axles and electric brakes, an increased power reserve capacity of 400 amp-hours (up from 200), additional LED lighting, and the addition of wiring management tracks and storage bins for better organization. Additional safety equipment for flaggers was also provided, such as generators and balloon lighting for nighttime flagger stations, upgraded

LED batons with 120 dB audible alerts, and both electric and traditional blow whistles for daytime use.

In the fall of 2024, CCWA was honored with the 2024 Water Environment Federation (WEF) Safety Award in recognition of its Innovative Safety Program, which promotes a strong culture of safety in both the water industry and the broader community. The WEF Safety Award acknowledges organizations with active, effective safety programs that prioritize safety excellence and share best practices for the benefit of the entire industry. This prestigious award was largely attributed to M.I.T.C.HTM and other technologies that ensure the safety of our employees.

Safety is our highest priority, and we are always striving to improve our safety program," says CCWA CEO H. Bernard Franks. "I am very proud of the innovations we have made over the past few years, and it is a tremendous honor to be recognized at the national level. We always value people over property and are committed to investing in a culture of safety to protect our Clayton County Water Authority family.'










NEWMAN Wetlands Center:

Broadening our Impact Through Clayton County Tourism Authority Grant











Melvin L. Newman Wetlands Center (NWC) continues to broaden its impact through innovative and community-centered programming, inclusive storytelling experiences, and more. In 2024, 2,300 participants explored, learned, and enjoyed time in nature at NWC.

In the spring, the card game Where in the World is Murtle? was officially printed. This card game, designed to inspire family fun through nature play, invites players to join Murtle, an adventurous common snapping turtle, on a journey of exploration, learning, creativity, and movement. Thanks to funding from the Clayton County Tourism Authority's Marketing and Tourism Grant, Newman Wetlands Center was able to design and print 1,500 copies of the game, encouraging players to engage with nature, think creatively, and have fun outside.

Grant funds were also used to support ongoing improvements to the annual Wetlands & Watershed Festival. Highlights included five storytellers who portrayed lesser-known wetland creatures, fostering connections between people and the natural world. Each storyteller was accompanied by an ASL interpreter.
